

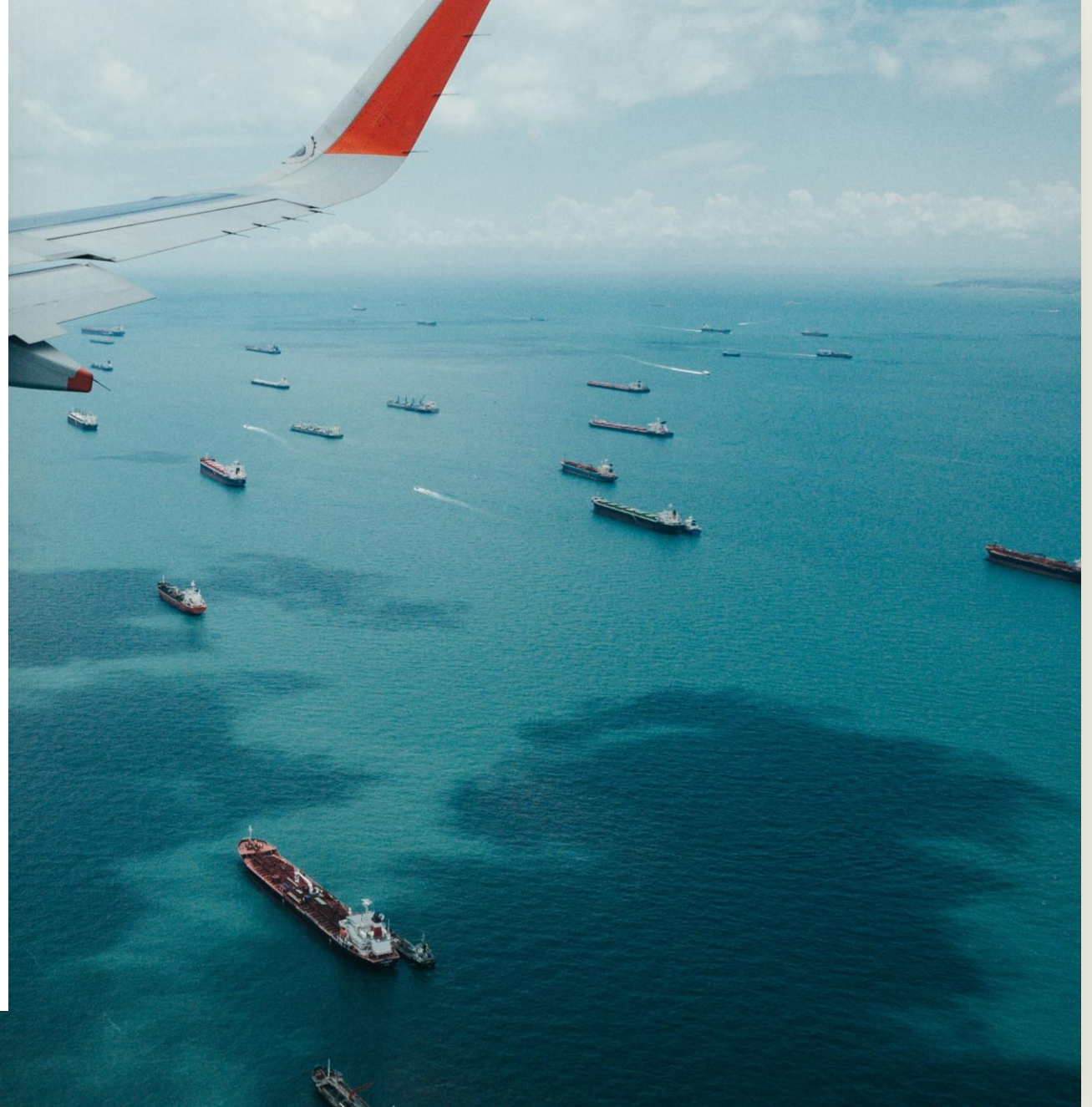

The conception of MAY International was initiated with one vision, that is to deliver services that transforms financial institutions (FIs).

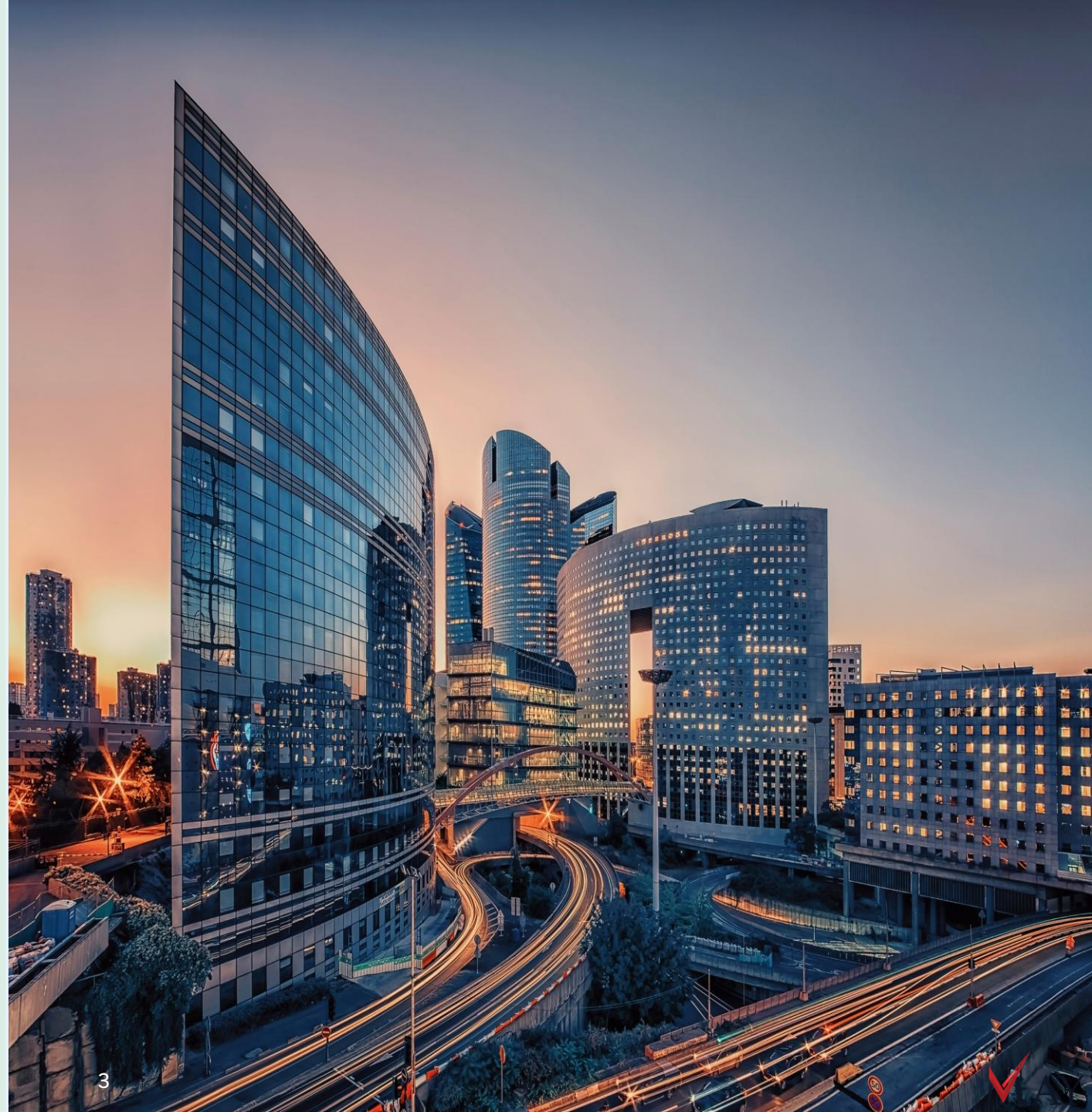

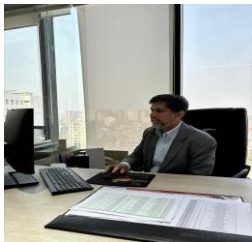
